Customer is responsible for the cost of delivering unit to Panasonic facility, while Panasonic will pay for the return transportation. For units out of warranty or customers outside of the continental USA shipping arrangements and cost (both ways) is the customer's responsibility.

This warranty is extended only to the original purchaser and is nontransferable. A purchase receipt or other proof of date of original purchase will be required before warranty service is rendered. Whenever the date of original purchase can not be satisfactorily determined, the date of manufacture of the unit will be deemed to be the effective date of the warranty. Lamp usage hours recorded into lamp memory chip need to be verified by Panasonic before lamp replacement is granted.
