OFFICIAL CONTEST RULES AND REGULATIONS

The Panasonic ShaveLikeAPro.ca Contest (the "**Contest**") is sponsored by Panasonic Canada Inc. (the "**Sponsor**"). **NO PURCHASE NECESSARY TO ENTER CONTEST.**

2. **ELIGIBILITY:** Contest is open to all lawful residents of Canada (excluding Quebec) who are of the age of majority in their province or territory of residence, except employees, representatives or agents of the Sponsor, its retail distributors, their respective advertising agencies and all persons residing in their respective households.

5. **ODDS OF WINNING:** The odds of an entry being selected depend on the number of Eligible Entries received for each Weekly Draw. For each weekly draw, unselected entries will be eligible for subsequent draws. Sponsor reserves the right to substitute a prize of equal or greater value.

The Sponsor will not be responsible for failed attempts to contact a selected entrant.
7. **SKILL TESTING QUESTION:** To be declared a winner, each selected entrant must answer correctly, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question. Any selected entrant who provides an incorrect answer will no longer be eligible to win. Prizes will be shipped to confirmed winners upon receipt of his/her Release Form. Prize fulfillment will be coordinated by the Sponsor with each confirmed winner.
8. **COLLECTION OF PERSONAL INFORMATION:** By entering the Contest, each entrant expressly consents to the Sponsor, its agents and or representatives, the storing, sharing and use of his/her personal

information submitted with his/her entry for (i) the sole purpose of operation and administration of the Contest and (ii) provided he or she has expressly consented at the time of entry, to receive marketing information from the Sponsor. No further informational or marketing communications will be sent to entrants who have not given their express consent. Notwithstanding this provision, by accepting the Prize, the winner consents to the use of their name, place of residence, voice, statements, and photographs or other likenesses for publicity, advertising or informational purposes in any medium or format without further compensation or notice.

9. **RELEASE:** Each selected entrant will also be required to sign a Release Form whereby he or she confirms compliance with the Official Rules, accepts the Prize as awarded, without substitution, and releases and holds harmless the Sponsor, their affiliates, subsidiaries, advertising and promotional agencies, their respective directors, officers, employees and assigns, its advertising and promotional agencies, and their representatives, successors and assigns (collectively the "Releasees") from and against any and all claims and liability arising out of or in any way connected with the operation of this Contest and use of a Prize.
10. **LIMITATION OF LIABILITY:** Sponsor assumes no responsibility for lost, stolen, delayed, damaged, misdirected, late or destroyed entries, notifications, responses, replies or any Release. 11. **GENERAL:** The Contest is subject to all federal, provincial and municipal laws and regulations. The Contest will be run in accordance with these Official Rules, subject to amendment by Sponsor. Sponsor reserves the right to withdraw, cancel or suspend the Contest, or to amend these Official Rules without prior notice or obligation, in the event of any accident, printing, administrative, or other error of any kind, or in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the Sponsor that interferes with the proper conduct of the Contest as contemplated by these Official Rules. By entering the Contest, participants will be deemed to have received and understood and agree to be bound by, and to comply with, these Official Rules and by the decisions of the Sponsor.

The Sponsor's rulings are final and without appeal in all matters related to the Contest and the awarding of the Prize. All Entries submitted become the property of the Sponsor without payment or any compensation and will not be returned.
