

## PANASONIC BATTERY EXTRA POWER AND WIN CONTEST MECHANICS

1. The overall contest commences on 1<sup>st</sup> December 2021 and closes on 31<sup>st</sup> January 2022 (“Contest Period”). All submissions are via **QR Code scan** on or before 31<sup>st</sup> January 2022.

For the weekly submission, the Organiser shall receive the submission of Entries on or before 23:59:59 of the last date of each Contest Week as tabulated below ;

- Week 1 : 01 December 2021 – 12 December 2021
- Week 2 : 13 December 2021 – 19 December 2021
- Week 3 : 20 December 2021 – 26 December 2021
- Week 4 : 27 December 2021 – 02 January 2022
- Week 5 : 03 January 2022 – 09 January 2022
- Week 6 : 10 January 2022 – 16 January 2022
- Week 7 : 17 January 2022 – 23 January 2022
- Week 8 : 24 January 2022 – 31 January 2022

2. To enter, contestants must submit the entry(ies) by sending via QR Code scan (microsite) to the stated url link ([http://bttag.co/Panasonic\\_mlgaW](http://bttag.co/Panasonic_mlgaW)):
  - Upload a printed and clear proof of purchase of any Panasonic Batteries ( refer to Participating Products) with a minimum value of **RM15.00** before applicable SST.
  - Answer a simple question: Panasonic Batteries deliver powerful performance. (**True / False**)
  - Include in the submission your name as per MyKad/MyPR, contact number, date of birth and active email address
3. Kindly note that no handwritten or cash bill receipts, delivery note, purchase order will be entertained, and entries with such receipts will be deemed incomplete. Only POS (Point of Sales) printed receipts will be accepted.
4. Kindly ensure that the details of the receipts are clear especially the name of the outlet by which the batteries are purchased from, together with the receipt number and date and time of purchase.

Each valid entry, completed with the required picture of receipt, fulfilled purchase requirement, correct answer and personal information received and approved by the Organizer during the Contest Period will be serialized (“Qualified Entry”). For every RM15.00 purchased of participating product in a single receipt, one (01) serial number will be allocated to the Entry. For example ;

- a. the single receipt of RM 30.00 of Panasonic participating products , two (02) serial numbers will be given.
- b. the single receipt of RM 45.00 of Panasonic participating products, three (03) serial numbers will be given.

5. **Participating Products** ; the following items purchased are eligible for this contest:

- Evolta Battery
- Alkaline Battery
- Manganese Battery
- eneloop Rechargeable Battery
- eneloop Charger Kit
- Lithium Coin Battery

6. Battery-operated appliances such as torch lights (LED Flashlight, LED Emergency Light, Standard LED Torch Light) and the One-2 LED Lantern are not eligible as purchase requirements.
7. Winners will be selected based on the following:
  - Clear and complete printed receipt(s)
  - Complete details received via QR Code submission (name as per MyKad/MyPR, contact number, date of birth and active email address) and approved by the Organiser.
  - Fulfilled Contest Purchase requirement
  - A correct answer to the question

#### **Shortlisting of Winners**

Each Participant is eligible to win maximum of **two (02)** prizes during the period of contest ;

- 1 x Weekly Prize and 1 x Grand Prize , or
- 1 x Weekly Prize and 1 x First Prize , or
- 1 x Weekly Prize and 1 x Second Prize

#### **Weekly Prize Winners Selection - 80 Weekly Winners x TNG e-Wallet Reload Pin RM50**

The shortlisted winners will be determined based on the serialized number of Qualified entries received during the **Contest Week Period**, for example: 500 eligible entries/serial numbers received during the **Contest Week Period**, e.g., 500 serial numbers ÷ allocated prizes = winning entry serial number. Illustration of computation is as follows:

$$500 \div 80 = \underline{\underline{6.25^*}}$$

(The multiplication number in this case is **6**)

The Weekly Prize winner is the **6th** serial number entry and subsequent serial numbers with the multiplication of 6.

Total of **80 winners** will be selected throughout each Weekly Period.

The rounding formula will be performed if the winning number of entries arises the decimal value, the number will be rounded down to the **nearest single digit number** and the multiple serial numbers will be selected as the winner.

#### **Grand Prize Winners Selection : 5 Winners x TNG e-Wallet Reload Pin RM2,000**

The shortlisted winners will be determined based on the serialized number of Qualified entries received during the Contest Period, for example: if there are 6,700 eligible entries/serial numbers received during the **Contest Period**, this number will be divided by 5. Illustration of computation is as follows:

$$6,700 \div 5 = \underline{\underline{1,340^*}}$$

The Grand Prize shortlisted winner is the **1,340\*** serial number entry and subsequent serial number with the multiplication of **1340**. Example of the shortlisted winning serial number; 1340\*, 2680\*, 4020\*, 5360\* and 6700\*.

Total of **5 winners** will be selected throughout the Contest Period.

The rounding formula will be performed if the winning number of entries arises the decimal value, the number will be rounded down to the **nearest single digit number** and the multiple serial numbers will be selected as the winner.

### **First Prize Winners Selection : 10 Winners x TNG e-Wallet Reload Pin RM500**

The shortlisted winners will be determined based on the serialized number of Qualified entries received during the Contest Period, for example: 6,700 eligible entries/serial numbers received during the **Contest Period**, will be deducted with the Grand Prize winner's Entry/Entries and divided by 10. Illustration of computation is as follows:

Assuming Grand Prize winner's entries = 10\* entries ;

$$6700 - 10* = 6690 \div 10 = \underline{\underline{669*}}$$

The First Prize shortlisted winners is the **669\*** serial number entry and subsequent serial number with the multiplication of **669**. Example of the shortlisted winning serial number; 669\*, 1338\*, 2007\*, 2676\*, 3345\*, 4014\*, 4683\*, 5352\*, 6021\* and 6690\*.

Total of **10 winners** will be selected throughout the Contest Period.

The rounding formula will be performed if the winning number of entries arises the decimal value, the number will be rounded down to the **nearest single digit number** and the multiple serial numbers will be selected as the winner.

### **Second Prize Winners Selection : 30 Winners x TNG e-Wallet Reload Pin RM300**

The shortlisted winners will be determined based on the serialized number of qualified entries received during the Contest Period, for example: if there are 6,700 eligible entries/serial numbers received during the **Contest Period**, this number will be deducted with the Grand Prize and First Prize winner's Entries and divided by 30. Illustration of computation is as follows:

Assuming Grand Prize and First Prize winner's entries = 62\* entries ;

$$6700 - 62* = 6638 \div 30 = \underline{\underline{221.2*}}$$

The Second Prize shortlisted winners is the **221\*** serial number entry and subsequent serial number with the multiplication of **221**. Example of the shortlisted winning serial number; 221\*, 442\*, 663\*, 884\*, 1105\*, 1326\*, 1547\*, 1768\*, 1989\*, 2210\*, 2431\*, 2652\*, 2873\*, 3094\*, 3315\*, 3536\*, 3757\*, 3978\*, 4199\* and so forth.

Total of **30 winners** will be selected throughout the Contest Period.

The rounding formula will be performed if the winning number of entries arises the decimal value, the number will be rounded down to the **nearest single digit number** and the multiple serial numbers will be selected as the winner.
